Police Department Report:

Chief Phillip Hubbard

Present

- Officer Drew Manson made a drug arrest.
- Chief Hubbard stated police department is still in the process of buying items from the DPS Grant that has been awarded to the police department.
- All items that are listed in the grant have been purchased or is in the process of being purchased. A
 phone call made to one of the point of contacts for the grant to request if the money could be
 recategorized/redistributed to other items the police department needs, such as laptops, breathalyzers,
 electronic fingerprinting, police tape and flashlights. The items listed above are acceptable to spend the
 money on and any remaining money left in one of the categories could be used to help purchase items in
 another category.
- Chief Hubbard stated the police department is working with school officer Matt Huffman to help keep the schools safe.

Fire Department Report

Interim Chief Mike Geurian

Present

Mayor asked Interim Fire Chief Geurian if he had anything to discuss. Mayor Riley stated the non-profit
organization has been dissolved and the fire department is currently trying to establish the bylaws.

 Mayor Riley stated he owes the fire department job descriptions for officer positions within the department and personnel policy.

Street Report (TAP Project) – was resubmitted to regional engineering office for changes requested permission to request bids.

- In July a letter was submitted requesting permission to solicit for bids for the TAP Project (sidewalks). This
 was discussed during the special council meeting on July 9th, 2024.
- Mayor contacted Trey Foster with CEA and asked what the holdup was with the bid solicitation The
 regional engineering in Russellville had an issue due to drainage. ARDOT requested from engineering
 group a correction.
- CEA has made the requested changes that were concerns of ARDOT and resubmitted the plan to ARDOT for permission to request to solicit bids.

General - Public Comment

Old Business:

Agenda Item A: Farm House Property: Ed and Lola Condley provided easement of 4 feet. Will close once Quit Claim deed is filed, and title insurance is completed.

- Mayor stated he spoke with the local business owners that owned the land that part of the AC unit is on for the Farm House Property. Ed and Lola Condley with Hector Hardware Store is providing easement.
- Mayor stated once the survey is completed and quit claim deed is issued, which is being taken care of by the seller, then it will go thru title insurance search and after that a closing date would be set. Mayor was not sure how long this process would take.

Agenda Item B: Fun Park Grant submitted

 The City of Hector has submitted the necessary paperwork for the Fun Park Grant, the deadline was the end of August 2024. Mayor is not sure when the announcement will be made for who has been awarded the grant.

Agenda Item C: Consideration of a resolution R24-23 authorizing the city to apply for Public Safety Equipment Grant and contracting with Barlow Consulting Services for Grant submission and administration and approving an appropriation of \$500.00

- The amount for the DPS Grant if awarded is up to \$75,000.00. This grant is 100% funded, meaning the city would not have to match the amount of the grant.
- This grant will allow for a purchase of a patrol vehicle. The amount if awarded will cover the vehicle plus
 any items needed to equip the vehicle for police purposes. Chief Hubbard has received an estimate for
 total equipped vehicle, he also stated he would like to buy locally due to if any maintenance is needed it
 would be easier to work with someone that is local.
- Chief Hubbard is working with Barlow Consulting Services on listing items needed for the police department in the grant and any other necessary paperwork needed for this grant.
- Chief Hubbard stated again the vehicle would be four-wheel drive and would stay at city hall until needed by one of the officers.
- Council member asked if anyone has reached out to Kristen a grant writer for Pope County, she would be
 willing to work with the City of Hector or Karen Barlow. She is a free resource that has worked with fire
 fighters in the county. A business card for her has been provided to the mayor.
- Mayor Riley read the proposed resolution aloud to council members.
- Resolution presented by council member:

Agenda Item D: Brown/Sikes building discussion. Consideration of a resolution R24-24 entering into a partnership with the Brown/Sikes board of directors for the purpose of establishing a Brown/Sikes Community/Senior Citizens center.

- Grant writer stated there is grant funding available for senior citizen centers, but typically one of the items they look for is if a senior citizen center is established already.
- Mayor has spoken to Lola Condley on proposing to enter into a partnership with the Brown/Sikes board of
 directors. They are going to reestablish the organization. If they can get the organization reestablished,
 then when applying for grants one of the requested items for having an active senior citizen center would
 be met.
- No known timeline on when the organization will be reestablished.
- The proposed resolution is for the City of Hector to enter into a partnership with the Brown/Sikes Board of Directors to establish a Brown/Sikes Community/Senior Citizen Center. This resolution is showing intent but is not bidding.
- Discussed on applying for next Fun Park Grant and discussed other grant/funding options such as Area
 on Agency, Handicap Play Area, DHS, and Historic Society. Each of these will have their own stipulations
 and requirements that will have to be reviewed and met when applying for funding.
- Resolution presented by council member: Resolution 2024-24: authorizing partnership between City of Hector and Brown/Sikes Senior Citizen/Community Center

New Business:

Agenda Item A: Council consideration of a resolution R24-25 authorizing the opening of a fire department Act 833 Account.

- Mayor Riley stated all assets distributed to the City of Hector this will allow the city to establish a fund and to pay appropriations and liabilities for the fire department.
- Mayor Riley suggested to council to open a separate account at Chambers Bank for the fire department for monies received from Act 833. The name of account would be City of Hector Volunteer Fire Department Act 833.
- The separate account would only be for money received from Act 833, this would make it easier to track and audit. The money received for this can only be spent on certain items.
- The Mayor and Recorder/Treasurer will be authorized signature bearers of the account.
- Mayor Riley read the proposed resolution aloud to the council members.
- Resolution presented by council member: Resolution 2024-25: to authorize Mayor or Recorder/Treasurer to open City of Hector Volunteer Fire Department Act 833 account at Chambers Bank

Agenda Item B: Council consideration of a resolution R24-26 authorizing an appropriation from the Act 833 Fund in the amount of \$7500.00 for the repair of a fire truck.

- Interim Fire Chief Geurian stated it was Fire Engine 651.
- Mayor stated the vehicle has been purchased but was in the shop for needed repairs.
- This appropriation can be paid by the Act 833 fund, Mayor asked Interim Fire Chief for the invoice.
- A list of acceptable and non-acceptable items that can be appropriated to the Act 833 Fund will be provided to the city.

Mayor Riley read the proposed resolution aloud to council members.

 Resolution presented by council member: Resolution 2024-26: to authorize an appropriation from the Volunteer Fire Department Act 833 Fund in the amount of \$7500.00 for purposes of repairs to Fire Engine 651. Motion made by: Carey McGee Motion 2nd by: Samantha Brashear Vote: Passed 100% (5/5)

Agenda Item C: Council consideration of resolution R24-27 authorizing an appropriation from the General Fund.

- The Hector Scholarship Gala will be October 5, 2024, at the Hector High School Cafeteria, starting at 6pm.
- The City of Hector has an opportunity to purchase tickets for this event. This would be good marketing
 and public relations for the City of Hector. Tickets available for \$200, \$300 and \$400.
- Council member suggested to purchase 8 tickets in the amount of \$400.00 for the police officers and their spouses to attend.
- Mayor Riley read the proposed resolution aloud to the council members.

 Resolution presented by council member: Resolution 2024-27: to authorize an appropriation from the General Fund in the amount of \$400.00 to the Hector Scholarship Gala for the purpose of marketing for the City of Hector. Motion made by: Samantha Brashear Motion 2nd by: Peggy Gregory Vote: Passed 100% (5/5)

City Council members review and approval of financial transactions.

Late public comment:

Member of the public asked when the board would be established for the Hector Volunteer Fire Department. Mayor stated the fire department is meeting and trying to establish their bylaws. Mayor suggested to the fire department to simplify the bylaws due to some of the items will be covered by the city personnel policy. If any major items come up the fire department would bring it to the city council, this is not for items covered under a standard budget. A budget is currently being established for the remainder of the year. If they have issues and cannot pass the bylaws, then the city could have a council meeting and ask council to amend Ordinance 2024-1 and appoint the three positions.
