**RESOLUTION AUTHORIZING THE SALE OF CITY OWNED PERSONAL
PROPERTY**

Be it resolved on this 19th day of February 2024, the City Council of the City of Hector,
Arkansas met in a regular session.

Wherefore, the City of Hector owns a Husqvarna Riding Lawn Mower that was
Purchased on May 10th, 2010 for use of the City of Hector for the purchase price of \$1,952.98.
This fixed asset has not been in use by the City of Hector.

Wherefore, Arkansas Code Annotated 14-54-302 (e) (1) states as follows: If personal
property of the municipality becomes obsolete or is no longer used by a municipality, the
personal property may be:

- A. (A) Sold at public or internet auction;
- B. (B) Sent to the Marketing and Redistribution Section of the Office of State Procurement;
- C. (C) Transferred to another governmental entity within the state; or
- D. (D) Donated under this section.

Now therefore the city council of the City of Hector hereby authorizes the mayor to sell said
personal property by bid to the highest bidder, without reserve. If no bids are received, the
property will be considered obsolete and be removed from the city fixed asset listing.

AFFIDAVIT

The City of Hector, Arkansas is in possession of the following real property:

- 1) 2010 Husqvarna YTH2348

Pursuant to Ark. Code Annotated 14-54-302:

(e)(1) If personal property of the municipality becomes obsolete or is no longer used by a municipality, the personal property may be:

- (A) Sold at public or internet auction;
- (B) Sent to the Marketing and Redistribution Section of the Office of State Procurement;
- (C) Transferred to another governmental entity within the state; or
- (D) Donated under this section.

2) If an item of personal property is not disposed of under subdivision (e)(1) of this section, the item may be disposed of in the landfill used by the municipality if the mayor or his or her authorized representative certifies in writing and the governing body of the municipality approves that:

- (A) The item has been rendered worthless by damage or prolonged use; or

(B) The item has:

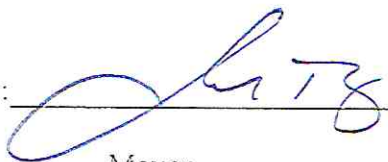
(i) Only residual value; and

(ii) Been through public auction and not sold.

(f)(1) A record shall be maintained of all items of personal property disposed of under this section and reported to the governing body of the municipality.

(2) The municipal fixed asset listing shall be amended to reflect all disposal of real estate and personal property made under this section.

In compliance with Arkansas law, I John Riley, Mayor of the City of Hector, Arkansas, certify that the above referenced real property is obsolete and is no longer in service to the City of Hector. Furthermore, the repair of this real property will not be cost effective for the citizens and taxpayers.
